Kosovo Prosecutorial Council based on Article 4, paragraph 1.14 and Article 22, paragraph 1 of the Law no. 03/L-224, namely Law on Kosovo Prosecutorial Council, in the meeting held on 14th of June 2017, has taken the following:

DECISION

- I. Request of Chief Prosecutor of the Basic Prosecution in Ferizaj on extending the temporary transfer of Prosecutor Arben Ismajli for a time period from six (6) more months, namely from 5th of July 2017 until 4th of January 2018 is approved.
- II. Secretariat is obliged to publish this Decision on the official websites of KPC and SP.
- III. This Decision enters into force on the day of its approval by Kosovo Prosecutorial Council.

Reasoning

Chief Prosecutor of the Basic Prosecution in Ferizaj, Mr. Shukri Jashari, has addressed to Kosovo Prosecutorial Council a request for extending transfer of Prosecutor Arben Ismajli to the respective Prosecution for six (6) more months. Initially, Chief State Prosecutor, Mr. Aleksandër Lumezi, has taken the Decision No. 202/2017 issued on 30th of May 2017, upon which he has temporarily transferred Prosecutor of the Basic Prosecution in Gjilan, Mr. Arben Ismajli in the Serious Crimes Prosecution Department of the Basic Prosecution in Ferizaj, for a time period from thirty days, namely from 5th of June 2017 until 4th of July 2017.

Chief Prosecutor Shukri Jashari has estimated that the 30 day transfer time is too short, therefore he has sought assistance for the Basic Prosecution in Ferizaj, namely Serious Crimes Prosecution Department, which, as already known, has a high number of cases and lacks Prosecutors serving in the named Department, and due to the aforementioned he has requested the transfer of the respective Prosecutor for six (6) more months.

Kosovo Prosecutorial Council based on the request of Chief Prosecutor Jashari, and taking into account current state in the named Prosecution which is facing with continuous lack of Prosecutors, in particular in the Serious Crimes Prosecution Department, for the purposes of ensuring functionality of this Prosecution, has decided as in the clause of this Decision.
